## Understanding the new local standards framework

# - a workshop for Independent Persons

Burnley Town Hall. Tuesday 23 October 2012

## **Background**

It has always been vital to the reputation of all in public life to be able to demonstrate the importance of high standards.

The Localism Act 2011 is transforming the way councils deal with standards cases. There is no longer a national framework, a national source of guidance and good practice or consistent procedures across the country. Instead there are opportunities for each council to develop an approach that suits their own needs and those of their local community. However, as part of those arrangements, councils must appoint at least one 'independent person' to support their work

This half-day workshop is an opportunity for those independent persons across the North West and Yorkshire to come together to share their early experiences and discuss some of the opportunities and challenges presented by the new framework as they put their new local arrangements in place.

#### Who should attend?

This event would particularly benefit the local independent persons which the Localism Act requires each council to have. It will also be of benefit to those councillors and officers who will be involved in day-to-day running of the local standards framework alongside the independent persons.

#### **Content**

The event will cover all aspects of the new arrangements, such as:

- The role of the new independent what does their new role entail and how does it differ from the old arrangements? Do they need to be less of a judge and more of a political influencer?
- Exploring the key principles behind Codes of Conduct and looking at what can go wrong
- Handling allegations how can the Independent Person help the monitoring officer to make the local process work well?

#### **Presenters**

The training will be led by **Paul Hoey of Hoey Ainscough Associates Ltd.** Hoey Ainscough Associates are working with individual local authorities and national bodies to promote effective local governance.

Before setting up the company he spent over ten years as the director in charge of strategy and stakeholder relations at Standards for England.

He has been the acknowledged national expert on the local government standards framework for the last decade and has worked with national organisations, individual authorities and groupings of authorities on implementation and development of both the old and new local standards arrangements as well as advising Standards for England, the Government and key national regulators and representative bodies on standards issues. He has given expert evidence to both the Parliamentary Select Committee and Committee on Standards in Public Life enquiries into local government standards.

He will be joined by his co-director **Natalie Ainscough** who spent nearly 6 years at Standards for England where she led a multi-disciplinary team in the development of statutory guidance on local standards arrangements. She also developed and implemented entity risk management systems on behalf of Standards for England designed to identify, assess and prioritise local risks to an authority's governance from standards issues.

Paul and Natalie will be supported by an experienced independent person who will be able to offer their own perspective on the role.
