### 1. INTRODUCTION

- 1.1 Section 51(1) of the Licensing Act 2003 outlines the procedure whereby a responsible authority may apply to the Licensing Authority for a review of a premises licence.
- 1.2 Section 52(3) of the Licensing Act 2003 states that the Authority must, having regard to the application and any relevant representations, take such of the steps mentioned in subsection (4) (if any) as it considers appropriate for the promotion of the licensing objectives.
- 1.3 The steps mentioned in subsection (4) are:
  - (a) to modify the conditions of the licence;
  - (b) to exclude a licensable activity from the scope of the licence;
  - (c) to remove the designated premises supervisor;
  - (d) to suspend the licence for a period not exceeding 3 months;
  - (e) to revoke the licence.

### 2. INTRODUCTION

- 2.1 The Snipe Inn, 387 Manchester Road, Audenshaw, M34 5RP is a licensed premises, the premises licence holder is Frederic Robinson Ltd. A copy of the premises licence is attached at **Appendix 1**.
- 2.2 A site plan, including an up to date photograph of the premises is attached at **Appendix 2**.
- 2.3 The premises had been visited on 9 and 15 October 2020 in relation to the failure to comply with coronavirus restrictions. Specifically the failure to ensure effective social distancing controls are in place, failure to manage customers and allowing people to attend a gathering in the premises not in accordance with the Coronavirus Regulations.
- 2.4 The issues were raised with the management of the premises. The Premises Licence Holder was also informed of the concerns and the failure of the management of the premises to comply.
- 2.5 Due to a serious and imminent threat to public health, on 16 October 2020 it was deemed necessary for the Council to serve a Direction Notice requiring the premises to close immediately. The Notice required the premises to remain closed until 2 November 2020.
- 2.6 Following the Direction Notice the premises remained closed until 12 April 2021. Before the premises reopened a meeting took place between Licensing, Greater Manchester Police and representatives of Robinson's on 3 February 2021. The purpose of the meeting was to discuss how the premises would comply with the Covid restrictions upon reopening. It was suggested by the authorities that a change of the Designated Premises Supervisor (DPS), formerly the tenant, Ms Sarah Harwood, was required. Following the meeting, an application was received on 1 March 2021 to specify Geoffrey Lee as the DPS.
- 2.7 On 29 May 2021, Police attended the Snipe Inn in response to a 999 call to fighting in the beer garden where a male was assaulted which turned into a brawl. The victim received a serious injury to the head.
- 2.8 On 12 June 2021 Police Officers came across a large scale fight involving over 30 people where all parties refused to engage with Officers. A witness later makes a call to Police to state they saw a male involved be purposely hit by a vehicle.

- 2.9 On Tuesday 6 July 2021, Greater Manchester Police executed search warrants at a number of premises linked to the tenant of The Snipe Inn, 387 Manchester Road, Audenshaw. One of the addresses searched was The Snipe Inn, during the search of the premises Officers found a cannabis farm in the upstairs accommodation of the premises with ten mature plants being grown. The electricity meter had been bypassed and a substantial sum of money was seized by Police.
- 2.10 The DPS at the time, Geoffrey Lee, who lived at The Snipe, 387 Manchester Road, Audenshaw and was on site at the premises at the time the warrant was executed. Mr Lee was arrested for being concerned in the production of controlled drugs.
- 2.11 At approximately 12:50pm on Tuesday 6 July 2021, PC Martin Thorley from Greater Manchester Police submitted an application to the Licensing Authority for an expedited review of the premises licence in accordance with s53A of the Licensing Act 2003. A copy of PC Thorley's application is attached at **Appendix 3**.
- 2.12 In addition, PC Thorley also submitted a certificate in accordance with s53A(1)(b), signed by Superintendent Rachael Harrison, to the effect that the premises is associated with serious crime. A copy of the certificate is attached at **Appendix 4**.
- 2.13 On 7 July 2021, an Interim Steps hearing took place. The decision of the Panel was to remove Geoffrey Lee as the DPS and immediately suspend the premises licence pending a review of the premises licence. A copy of the decision letter in relation to this hearing is attached at **Appendix 5**.

### 3. REPRESENTATIONS & EVIDENCE SUBMITTED

### 3.1 TMBC Licensing Authority

A representation has been received by Rebecca Birch, Regulatory Compliance Officer on behalf of the Licensing Authority. This is attached at **Appendix 6**.

### 3.2 Greater Manchester Police

Further evidence has been received from PC Thorley on behalf of Greater Manchester Police, a statement is attached at **Appendix 7**.

### 4. HOME OFFICE GUIDANCE

- 4.1 In determining this review, the Panel must have due regard to the Guidance issued by the Home Office under section 182 of the Licensing Act 2003 and the Council's Statement of Licensing Policy 2016-2021 published pursuant to s5 of the Licensing Act 2003.
- 4.2 The current guidance issued by the Home Office under section 182 of the Licensing Act 2003 deals with the Powers of a Licensing Authority on the determination of a review, with particular attention being drawn to sections 12.22, 12.23 and 12.24, where a Licensing Authority considers action under its statutory powers:
  - 12.22 The licensing authority must hold a full review of the premises licence and determine the review within 28 days after the day of receipt of the chief officer's application. There can be no adjournment of the hearing or delay in reaching a determination beyond the end of the 28 day period. This must take place even if the chief officer asks to withdraw his application or representations. At the review hearing, the licensing authority must consider what steps are appropriate for the promotion of the licensing objectives taking into account any change in circumstances since any

- interim steps were imposed, consider any relevant representations, and review the interim steps already taken (if any).
- 12.23 In making its final determination the steps the licensing authority can take are:
  - the modification of the conditions of the premises licence;
  - the exclusion of a licensable activity from the scope of the licence;
  - the removal of the designated premises supervisor from the licence;
  - the suspension of the licence for a period not exceeding 3 months; and
  - the revocation of the licence.
- 12.24 Modification of the conditions of the premises licence can include the alteration or modification of existing conditions or addition of any new conditions, including those that restrict the times at which licensable activities authorised by the licence can take place.

### 5. CONCLUSION AND OPTIONS FOR THE PANEL

5.1 The Panel is requested to consider the content of this report and appendices and any oral evidence/submissions put forward at the hearing and to determine this review and to take such steps (if any) as it considers appropriate for the promotion of the licensing objectives. The steps available are set out at the front of the report.

### **ANNEXES**

### Annex 1 - Mandatory conditions

### 1. All supplies of alcohol

- 1. No supply of alcohol may be made under the premises licence-
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### 2. Exhibition of films

- 1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.
  - 3. Where:
  - (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question; admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- 4. In this section "children" means any person aged under 18; and "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c39) (authority to determine suitability of video works for classification).

### 3. Door Supervision

- 1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:
- (a) Be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
  - (b) Be entitled to carry out that activity by virtue of section 4 of the Act.
  - 2. But nothing in subsection 1 requires such a condition to be imposed:
- (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c12) (premises with premises licences authorising plays or films); or
  - (b) in respect of premises in relation to:
- (i) Any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising films or under a gaming licence, or
- (ii) Any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.

- 3. For the purposes of this section:
- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act,
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

## 4. Age Verification Policy

- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.

### 5. Irresponsible Drinks Promotions

- 1. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) Games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (e) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

### 6. Free Potable Water

The responsible person must ensure that free petable water is provided on request to customers where it is

reasonably available.

#### 7. Alcoholic Drinks Measures

- 1. The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

#### 8. Permitted Price of Alcohol

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
- (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
  - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

## (b) The prevention of crime and disorder

- (i) A sign will be displayed on the premises indicating the normal hours during which the sale of alcohol is permitted.
- (ii) No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.

### (c) Public safety

- (i) All fire doors will be maintained effectively self-closing and shall not be held open other than by approved devices.
- (ii) Notices detailing the actions to be taken in the event of fire or other emergencies, including how the fire brigade shall be summoned, are to be prominently displayed.

### (d) The prevention of public nuisance

- (i) A sign will be located at the exit(s) requesting that the customers leaving the premises do so quietly and with consideration to neighbours.
  - (e) The protection of children from harm
- (i) No one under the age of 18 will be allowed to enter or remain on the premises after 21.00 save on Christmas Eve and New Years Eve when the time will be 23.00 11

(ii) Anyone who appears to be under the age of 18 and who is attempting to buy alcohol must be required to produce proof of age before such a sale is made.

### **Non Standard Timings**

May open for an additional 60 minutes on the day when British Summer Time Commences.

CONDITIONS ADDED FOLLOWING REPRESENTATION FROM RESPONSIBLE AUTHORITY

#### 1. Entertainment to be Inaudible

Noise generated by regulated entertainment shall be inaudible at the nearest noise sensitive location after 11.00pm

CONDITIONS AGREED WITH LICENSING FOLLOWING VARIATION APPLICATION ON 30TH JANUARY 2019

#### 1. CCTV

A tamper-proof digital colour CCTV system must be installed and maintained at the premises to the reasonable satisfaction of Greater Manchester Police.

The system must run and record continuously for 24 hours a day, 7 days per week and recorded footage must be stored for a minimum of 28 days.

The system must provide a clear head and shoulders view to an evidential quality on every entry/exit route and within any other vulnerable areas as identified by Greater Manchester Police.

The system must cover the outside areas i.e. beer garden/smoking shelter including the perimeter of the building.

Recorded footage must be provided to a representative of any responsible authority upon request when the premises are open to the public, so long as said request is made in accordance with the provisions of the Data Protection Act or any subsequent or alternative legislation. Such footage must be provided in an immediately viewable format and must include any software etc. which is required to view the footage. Any discs, portable drives or other storage media onto which footage is transferred must be provided by the premises and sufficient stock of such storage media must be kept on the premises at all times.

A member of staff who is trained to operate the system and supply footage must be present at the premises at all times when licensable activities are taking place.

The Designated Premises Supervisor must ensure that the CCTV system is checked at least once every week by a suitably trained member of staff. This check must include the operation of the cameras, the recording facilities, the facilities for providing footage and the accuracy of the time & date. A written record of these checks must be kept, including a signature of the person carrying out the check. This written record must be kept on the premises at all times and made available to a representative of any responsible authority on request.

Suitable signage informing customers that a CCTV system is in operation must be placed in prominent positions within the premises, including information on the Data Protection Act and the Human Rights act.

A monitor showing the various cameras in operation will be located within the bar area and in a prominent location.

#### 2. Incident Book

An incident book (with the pages numbered sequentially) must be kept on the premises and be made available for inspection by responsible authorities. The incident book must be used to record the following:

- (i) Any incident of violence or disorder on or immediately outside the premises
- (ii) Any incident involving controlled drugs (supply/possession/influence) on the premises
- (iii) Any other crime or criminal activity on the premises
- (iv) Any refusal to serve alcohol to persons who are drunk (On sale and off sale premises only)
- (v) Any refusal to serve alcohol to under 18s or anyone who appears to be under 18
- (vi) Any call for police assistance to the premises
- (vii) Any ejection from the premises
- (viii) Any first aid/other care given to a customer

### 3. Drug Policy

The management of the premises must introduce a strict zero tolerance policy in respect of the use and/or supply of illegal drugs on the premises. The policy to include checks of the toilet areas at least every two hours whilst the premises are open and suitable signage to be placed in prominent areas within the premises.

### 4. Challenge 25

The premises must operate a Challenge 25 scheme at the premise in relation to age verification for alcohol sales and other age-restricted products. Signs and/or posters must be displayed in prominent positions inside the premise to inform customers of this condition.

### 5. Staff Training

Any staff employed at the premises will receive credible and appropriate training on first appointment and at least every six months thereafter. Training will include input on preventing underage sales, sales of alcohol to people who are drunk, application of the drugs policy and any other relevant matters. A written record will be kept of all training carried out. This record must be kept on the premises and made available for inspection by any responsible authority.

### 6. List of Authorised Persons

The Designated Premises Supervisor must maintain a written record of all members of staff who are authorised to sell alcohol. This record must be kept on the premises at all times and be made available to a representative of any responsible authority on request.



At approximately 0600hrs on Tuesday 6th July 2021 the search warrants were executed at three addresses by Officers from Greater Manchester Police.

The Snipe Inn premises has been searched. During the search of the premises it was found that there was a cannabis farm on the premises with ten plants being grown. The electricity meter has been bypassed and a substantial sum of money has been siezed by Police.

The Designated Premises Supervisor is Geoff Lee who resides on site at The Snipe, 387 Manchester Road, Audenshaw. Geoff Lee was on site at The Snipe at the time the warrant was executed and is currently in custody having been arrested for being concerned in the production of controlled drugs.

This investigation is currently in its infancy, though there were also positive results at the other related premises and police enquiries are continuing.

As this premise has been found to have been used for the cultivation of Cannibis and is currently a Public House which trades seven days per week and is occupied and managed by the current DPS and tennant, there can be no doubt that the cultivation of Cannibis has been undertaken with the full knowledge of both the tennant and the Designated Premises Supervisor. The cultivation of Cannibis is deemed to be a serous offence and is a clear breach of the Licensing Objectives.

Given the involvement of the arrested person in the day to day running of these premises there is an immediate risk of further criminality taking place at the Licensed Premises if it was to remain open.

Previously, there have been concerns over the management of the premises, including during the Health Protection Regulations restrictions where the management of the premises failed to ensure effective social distancing controls were in place and manage the behaviour of customers on the premises in order to prevent the spread of coronavirus.

Despite previous attempts to engage with the DPS and management of the premises to ensure that the premises was compliant with the regulations, the appropriate action was not taken. This resulted in a Direction Notice being served by the Council, requiring the premises to close on 16 October 2020. The premises remained closed until 12 April 2021.

On 3 February 2021 a meeting took place with representatives of Frederic Robinsons Ltd (PLH) which resulted in a change of DPS being applied for on 1st March 2021. It is to be noted that the old DPS remained as tennant despite the concerns raised by the Authorities.

Ahead of reopening the premsies, I met with the Business Development Managerr, Tony Massey and Geoff Lee on 7 April 2021 in an attempt to engage with and work with all partie Involved In the running of the premises and discuss the plans for moving forward, given the appointment of the new DPS.

Further meetings have taken place on Tuesday 22<sup>nd</sup> June 2021 where I met with the Business Development Manager at Frederic Robin Ltd, Unicorn Brewery, Lower Hillgate, Stockport, where the following (two separate) crimes, which occurred at the premises, were discussed.

<u>Log 2805-29052021 CRI/06GG/0011334/21</u> refers to an incident at the Pub where Police have attended as a result of a 999 call to fighting in the beer garden of the premises. A male was assaulted in an unprovoked assault which turned into a brawl. The victim received S.47 level injury to the head. CCTV in relation to this incident has been seized.

<u>Log 2782-12062021 and CRI/06GG/0012584/21</u> Officers come across large scale fight involving 30+ people and all parties refuse to engage. A Witness to incident later calls the Police to state they saw a male involved be purposely hit by a vehicle.

A crime for a Section 18 - grievous bodily harm with Intent has been submitted. CCTV in relation to this incident has been selzed.

On Tuesday 29th June 2021 Rebecca Birch from TMBC and I attended at the Snipe where we met with Tony Massey, the tennant and the DPS. During this meetin I expressed my concerns about the recent incidents at the premises and the fact that previously volunteered door staff had been removed from the premises. It is the case that when the previous DPS was in post that there were a number of door staff volunteered who were seen to be present at the premises on key dates and weekends. These door staff were removed on the appointmnt of Geoff Lee for what are described as financial reasons. The PLH was not in support of re-introducing door staff for weekends and key dayes.

Given the results of the search warrant I now have additional concern that this premises will become a focal point for repucutions and repisals giving rise to further incidents of serious crime and disorder and putting the safety of members of the public at risk.

In order to ensure the licensing objectives and the prevention of crime and disorder is being promoted, Greater Manchester Police request that the licensing authority consider the suspension of the premises licence until the full review is heard before the committee.

## **INTRODUCTION**

The Police requested that the application be considered in private due to the ongoing criminal investigation. The Police did not seek to exclude the Licence Holder and its legal representative from the private part of the hearing.













There was no objection from the Licence Holder.

The Panel briefly retired to consider the issue. The meeting was re-convened and the following decision was announced to the hearing:

### **EXCLUSION OF PRESS AND PUBLIC**

With reference to Schedule 12A of the Local Government Act 1972 (as amended) and Regulation 14 of the Licensing Act 2003 (Hearings) Regulations 2005, that the press and public be excluded for the next part of the meeting on the grounds that, having applied the public interest test, the hearing or part of it, being in public is outweighed by the public interest in the hearing or part of being held in private.

The hearing moved to a private hearing.

### Mr Mike Robinson, Regulatory Services Manager, Tameside MBC

Mr Robinson presented the report to the Panel. Additional information relating to the licensing history of the premises was referred to.

Section 53A of the Licensing Act 2003 outlines the procedure whereby the police may apply to the Licensing Authority for an expedited review of a premises licence.

At approximately 12:50pm on Tuesday 6 July 2021, PC Martin Thorley from Greater Manchester Police submitted an application to the Licensing Authority for an expedited review of the premises licence in accordance with s53A of the Licensing Act 2003. A copy of PC Thorley's application was attached at Appendix 1 to the report to the Panel.

In addition, PC Thorley also submitted a certificate in accordance with s53A(1)(b), signed by Superintendent Rachael Harrison, to the effect that the premises was associated with serious crime. A copy of the certificate was attached at Appendix 2 to the report to the Panel.

Section 53A of the Licensing Act 2003 required the licensing authority, on receipt of an application for an expedited review, within 48 hours of the time of its receipt, to consider under section 53B whether it was necessary to take interim steps pending the determination of a review of the premises licence.

The interim steps the licensing authority must consider taking were:

- (a) The modification of the conditions of the premises licence;
- (b) The exclusion of the sale of alcohol by retail from the scope of the licence;
- (c) The removal of the designated premises supervisor from the licence,
- (d) The suspension of the licence.

## PC Martin Thorley, Police Licensing Officer Greater Manchester Police

PC Thorley presented the application on behalf of Greater Manchester Police.

At approximately 06:00 on Tuesday 6 July 2021, Greater Manchester Police executed search warrants at a number of premises linked to the tenant of The Snipe Inn, 387 Manchester Road, Audenshaw. One of the addresses searched was The Snipe Inn.

During the search of the premises, Officers found a cannabis farm in the upstairs accommodation of the premises with ten mature plants being grown. The electricity meter had been bypassed and a substantial sum of money had been seized by Police.

The Designated Premises Supervisor, Geoffrey Lee, who resided on site at The Snipe, 387 Manchester Road, Audenshaw, was present at the premises at the time the warrant was executed. Mr Lee was currently in custody having been arrested for being concerned in the production of controlled drugs.

Greater Manchester Police had concerns that the management of the premises were failing to promote the licensing objective of the prevention of crime and disorder due to serious crime regarding the cultivation of Cannabis being present on the premises.

The Police submitted that the powers contained under Section 53A of the Licensing Act 2003 were appropriate to be exercised.

In the interim, Greater Manchester Police, whilst noting the voluntary actions taken by the licence holder, requested that the Licensing Authority considered suspension of the premises licence until the full review is heard before the Panel. The Police view was that there was a risk of further criminality taking place on the premises if it were to remain open.

PC Thorley had included details of recent issues with the management of the premises. Breaches during covid – change of DPS – closed following direction up to 12/4/21.

Meetings had been held with the area manager.

Miss Harwood (previous DPS) was now a tenant.

There had been previous/recent assaults/fights at the premises.

Persons banned from other premises had been allowed into the Snipe.

The absence of door staff at the premises under the current DPS remained a concern for the Police.

The Licence Holder had co-operated. There remained some disagreement over the need for door staff at the premises.

The Police view was that the extent of the cannabis cultivation on the premises was such that the tenant (former DPS) and current DPS must have known of the extent of the criminality occurring on the premises. The former DPS remained as tenant despite concerns.

PC Thorley presented photos to the hearing regarding the search of the premises undertaken by the Police. The photos indicated an extensive and organised cannabis cultivation in the residential part of the premises.

Mr Lee's takeover as DPS resulted in the door staff being removed. The Police consider that this had contributed significantly to the recent issues.

### **Licence Holder**

The following submissions were made by Ms Faud and Mr Massey on behalf of the Licence Holder:

- Robinsons was a family run business and had been so since 1849. The company owned/operated a large number of licensed premises.
- There were very few issues with its premises as the company was very reactive to issues and working with the Police and other agencies.
- The premises had previously been closed voluntarily by the Company when issues arose.
- Risk assessment for door staff undertaken.
- Agreeable to a requirement that any new DPS engage with Pub Watch.
- Vehicle recognition was being considered for the premises car park to help with security at the premises and help promote the licensing objectives.
- The former DPS and current tenant was resident under the terms of a tenancy at will. 24
  hours notice was given yesterday to the tenant and she was due to leave today.
- The property was to be secured against re-entry (with a caretaker in place).
- The licence holder had no knowledge of the criminal activity. Mr Massey/Mr Bradford from Robinsons had not been in living quarters for 16 months or longer. A recent attempt to gain access was not successful.
- The photos presented by the Police were from the living quarters of the premises.

- The Licence Holder intended to keep the premises open. The premises to be a managed site rather than tenanted in the foreseeable future.
- The Licence Holder was keen to work with the Police to identify a way forward for the premises.
- Interim steps the licence holder has or is to remove the current DPS. The Licence holder said that a suspension of the licence was not necessary as without a DPS the premises could not operate the licence. Any new DPS would be subject to approval from the Police.

The Panel retired at 11.25am to reach its decision and returned at 11.50am. The decision was given in public.

#### **DECISION / REASONS**

In determining this matter, the Panel had taken into account:

- all oral and written evidence and submissions
- the Council's Statement of Licensing Policy
- the relevant sections of the Licensing Act 2003 and Regulations made thereunder
- the Guidance issued by the Secretary of State under section 182 of that Act (including the specific Guidance issued in relation to s53A), and the licensing objectives.

The Panel was satisfied that there was clear evidence that for the purposes of s53A there had been a serious crime committed on the premises.

The Panel noted the licence holder's intention to retain the licence going forward and to work closely with the police to avoid a repetition of recent events. The Panel welcomed the immediate voluntary steps taken by the Licence Holder, namely, proposed removal of the DPS, proposed removal of the tenant, the securing and voluntary closure of the premises pending the appointment of a new DPS (and the review of the licence).

However, having regard to the circumstances and the recent issues with management of the premises and the risk of further criminality, the Panel considered that it was necessary, in order to promote the crime and disorder objective, to take interim steps pending determination of a review of the premises licence.

The Panel considered all available options and concluded that the appropriate and proportionate interim steps in this matter were that:

- 1. The designated premises supervisor be removed (this was included to formalise the step proposed by the licence holder)
- 2. The premises licence be suspended pending a review of the premises licence (to be within 28 days after the day of receipt of the s53A application). The Panel considered that this step was necessary as the re-appointment of the DPS was not the only issue to be considered with regard to these premises, going forward.

The suspension would take effect immediately and remain in force until the determination of the review (and the outcome of any appeal in relation to the review decision). A review hearing would take place within 28 days of the submission of the application.

### NOTE:

For the purposes of section 53B(5)(b) of the Licensing Act 2003 immediate notice of this decision was given orally to all parties at the hearing (with a written decision with reasons to follow).

I am the above named person. I am employed by Tameside Metropolitan Borough Council as a Regulatory Compliance officer within Public Protection, Environmental Services. I have been employed in this role since January 2020. Within this role I deal with Licensing and Environmental Protection which includes noise pollution.

Greater Manchester Police in its capacity as a responsible authority applied for an expedited review of the premises licence due to serious crime. This application was submitted on 6 July 2021 and this statement is provided in support of that application.

On 9 October 2020, the premises was visited by Officers and issues were identified, specifically the failure to ensure effective social distancing controls are in place and failure by doorstaff and management at the premises to manage customers. During this visit, these issues were raised with Mr Fox, the premises manager at the time of the visit. The Premises Licence Holder was also informed of the concerns and the failure of the management of the premises to comply.

Further visits were conducted on 15 October 2020 where Officers reported a live stream of a funeral with around 20 customers attending the gathering with food being delivered from an outside caterer. In accordance with the Regulations, people were unable to gather and meet indoors unless they are from the same (or linked) household. There were exemptions for wakes, but this could be for no more than 15 people. Further, the Regulations also required that any food or drink must be ordered from and served to a customer who remains seated.

On 16 October 2020, a direction notice was served on the premises due to the serious and imminent threat to public health and was necessary for preventing, protecting against the spread of infection by coronavirus. The premises was required to close with no persons admitted to the

support this, it is felt that it is appropriate that conditions are amended to include;

**Door Staff** 

Prior to each occasion that the premises carries on licensable activities, a risk assessment will be carried out to determine whether door supervisors are required and an appropriate number of door supervisors will be utilised in accordance with said risk assessment. As a minimum, if the premises intends to sell alcohol beyond 00:00 then a minimum of two SIA registered door

supervisors will be utilised from 21:00 until twenty minutes after the premises closes.

**Door Staff Log** 

A Door Supervisor Log shall be correctly maintained at the premises. This will include the following details:

(i) The door staff names, dates of birth and home addresses;

(ii) Full details, name, address and contact number of employment agency used

And for each individual period of trading:

(iii) The name of the individual member of door staff

(iv) His/Her Security Industry Authority licence number

(v) The time and date He/She starts and finishes duty

(vi) The time of any breaks taken whilst on duty

(vii) Each entry shall be signed by the door supervisor, DPS or nominated person

**Drug Policy** 

The management of the premises must introduce a strict "zero tolerance" policy in respect of the use and/or supply of illegal drugs on the premises. The policy to include checks of the toilet areas every half-hour whilst the premises are open and suitable signage to be placed in prominent areas within the premises. A written record of these checks must be kept on the premises at all times and

made available to a representative of any responsible authority on request.

This was as a result of a positive search warrant being executed earlier on 6<sup>th</sup> July 2021 at the Licensed Premises under s8 PACE and s23 Misuse Of Drugs Act.

In my capacity as Licensing Officer I have been made aware of numerous incidents which have been reported as occurring at / or in relation The Snipe Inn. As a result of knowing this on Tuesday 20<sup>th</sup> July 2021 I caused a search for incidents at The Snipe Inn, Audenshaw for dates between 1<sup>st</sup> January 2020 and 17<sup>th</sup> July 2021.

I have reviewed each of the incidents individually and the following are the list of incidents giving relevant detail of the reports in relation The Snipe PH Licensed Premises.

The majority of incident have occurred at weekend and have been recorded as occurring late in the evening and towards the terminal hour for the provision of alcohol.

The incident listed as 000391-06072021 relates to the above mentioned warrant. The premises closed on this date no further incidents have been recorded.

As of today Police investigations into this matter are ongoing.
