There were no declarations of interest submitted.

20. MINUTES

RESOLVED

That the Minutes of the meetings of the Speakers' Panel (Liquor Licensing) held on 4 April 2023 be approved as a correct record.

21. APPLICATION FOR A PREMISES LICENCE - BEAN AND BUN, 4 BROADOAK CRESCENT, ASHTON-UNDER-LYNE. OL6 8QE

Ms Lee, Regulatory Compliance Officer, presented the report to the Panel and outlined the procedure whereby an application can be made for a premises licence under Section 17 of the Licensing Act 2003

Ms Lee presented the report to the Panel and identified the steps available to the Panel in determining the application.

Mr Robinson informed the Panel of the brief background to the application as set out in the report.

On 27 February 2023 an application for the grant of a Premises Licence was made by Bean & Bun Ltd. The application sought the authorisation of the sale of alcohol for consumption on the premises only.

The premises opening hours were Monday – Sunday 06:30 – 23:30.

The application sought the authorisation of the sale of alcohol for consumption of the premises on Monday to Sunday 10:30 - 23:00.

The applicant had agreed the following conditions with the Licensing Authority:

- CCTV
- Challenge 25
- Refusals book
- Staff training
- List of authorised persons

- Alcohol sales will be ancillary to the purchase of food
- No vertical drinking at the premises
- No lager, beers or cider above 6.5% abv to be sold

A representation was received from a member of the public which related to concerns regarding the proposed sale of alcohol, which was feared would cause inconvenience and nuisance to residents and nearby business owners, negatively impacting their lives.

The following submissions were made by Ms Coramatia in support of the application:

- Bean & Bun Ltd had been trading for the past 6 months and had a good reputation
- They were a family friendly café from 8am to 5pm the evening
- They were seeking to introduce a new Indian restaurant in the evening from 5pm until 10pm where they could sell alcohol for consumption on the premises
- Customers have decided not to eat at the premises on occasions as they do not sell alcohol
- The focus would be on the food and alcohol will be a drink option with food
- There were no issues with the police, fire department and all their customers were happy; there had been no objections from customers

In response to questions from the Panel, Ms Coramatia confirmed:

- The premises had a 30 people capacity
- They wanted the licence to sell alcohol from 10.30am in the morning until 10.30pm at the latest
- There had been no complaints about the business
- The police were encouraging of their business when they first opened and they were the premises' first customers
- Ms Coramatia would be the Designated Premises Supervisor and would be at the premises 90% of the time to ensure the licensing objectives were promoted

Representations were then made by a member of the public in objection to the Application:

- The main concern was safety
- She has been doing business [as a Chinese take away] for 14 years and had countless incidents where drunk people had caused nuisance and violence including shouting, sweating, drunk driving, breaking windows and cooking equipment
- This has caused disruption to the business and made residents in the area feel unsafe
- On one occasion she was physically attacked this caused her children to become extremely afraid as they live upstairs
- How could the Licensing Authority keep them safe if Bean & Bun Ltd sell alcohol?
- There were shops in the area that sold alcohol and a pub over the road and submitted this was a bit much in a small area
- Plans needed to be made for customer parking if they were considering opening a restaurant
- The road at the front of the shops was very small and can only fit a few cars which would be unsuitable for a restaurant
- There had been some illegal parking on the pavement including blocking entrances which showed disregard for other stores
- There was a lot of school traffic in the area
- If the premises sold alcohol they should provide a private parking space for their customers so other people in the area weren't disrupted

In response to questions, the member of the public confirmed:

- They had reported issues of violence to Greater Manchester Police and by the time the police arrived, the perpetrators had gone, but the police did investigate it
 - Ms Lee stated that she asked the Police if there were any reports made and the police were unable to find any reports of anything

- They were unable to say where the drunk people had come from but they assumed it's places serving alcohol in the area however they were unable to ask them
- They were not suggesting they had come from Bean & Bun as they hadn't sold alcohol yet however if they did sell alcohol, this would be one of their concerns
- Issues of nuisance haven't been reported to the Council they had discussed this privately with the premises

The Panel then heard brief closing submissions from all parties.

Members of the Panel then retired to carefully consider the written submissions, representations and questions and answers during the hearing in addition to all the information provided. The Panel were accompanied by the Legal Representative and the Principal Democratic Services Officer, who provided legal and procedural advice only and took no part in the decision making process.

DECISION/REASONS

In determining the matter, the Panel had due regard to:

- the report to Panel
- the application and representations received
- all oral and written evidence and submissions
- the Council's Statement of Licensing Policy
- the relevant sections of the Licensing Act 2003 and Regulations made thereunder
- the Guidance issued by the Secretary of State under section 182 of that Act.

The Panel determined the application pursuant to section 18(3) of the Act having regard to the relevant representations and the requirement to take such steps as it considered appropriate to promote the licensing objectives.

The key points identified by the Panel were as follows:

- 1. The Premises were seeking a licence to permit the sale of alcohol for consumption on the premises between the hours of 10:30am and 11pm
- 2. The Premises intend to open as an Indian restaurant past 5pm in the evening and would like to offer alcohol to customers for consumption with their meals
- 3. An objection has been received from a member of the public who worked at the premises next door in relation to concerns about the licensing objectives not being promoted due to drunk and disorderly people
- 4. The member of the public was also concerned that there was limited parking available outside the premises situated outside the 4 stores along Broadoak Crescent
- 5. The Panel noted that the objectors stated they would not have any issues at all if the premises could provide private parking
- 6. No representations were made by Greater Manchester Police or any public bodies
- 7. The Panel had no evidence before it of any of the four licensing objectives being undermined

The Panel considered all available options.

On balance, having carefully considered all of the available information, the Panel concluded that the premises licence should be granted subject to the imposition of conditions agreed prior to today's hearing and further conditions are to be imposed.

STEPS TAKEN PURSUANT TO S52(4) LICENSING ACT 2003

The step that the Panel considered appropriate to promote the licensing objectives was to grant the premises licence subject to conditions agreed prior to today's hearing together with a further conditions relating to the supply of alcohol as follows:

Supply of alcohol (for consumption on premises only)

Monday to Sunday 12:00pm until 10:30pm

The Panel were of the view that serving alcohol from 10.30am would be too early and felt that 12pm was a more appropriate time to supply alcohol to customers during the day.

The Panel noted the concerns raised by the member of the public with regard to parking issues however this was a private issue and beyond the remit of the Panel's powers at the hearing today.

If any issues arose with regard to licensed premises which could not be resolved, a formal review of a licence could take place. An application to vary a licence could also be made.

The Panel thanked those attending the hearing for their contribution and assisting the Panel in reaching its decision.

That the premises licence be granted subject to conditions agreed prior to today's hearing together with a further condition relating to the supply of alcohol as follows:

Supply of alcohol (for consumption on premises only) Monday to Sunday 12:00pm until 10:30pm



1. INTRODUCTION

- 1.1 Under Section 34 of the Licensing Act 2003 a premises licence holder may apply to the Licensing Authority for a variation of a premises licence.
- 1.2 Section 35(3) of the Licensing Act 2003 states that where relevant representations are made in respect of an application, the Authority must:
 - (a) hold a hearing to consider them, unless the Authority, the Applicant and each person who has made such representations agree that a hearing is unnecessary, and
 - (b) having regard to the representations, take such steps as mentioned in subsection (4) (if any) as it considers appropriate for the promotion of the licensing objectives.
- 1.3 The steps mentioned in subsection (4) of the Licensing Act 2003 are:
 - a) to modify the conditions of licence
 - b) to reject the whole or part of the application

and for this purpose the conditions of the licence are modified if any of them are altered or omitted or any new condition is added.

2. REPORT

- 2.1 Fletchers Arms, 445 Stockport Road, Denton, M34 6EG is a licensed premises. A site plan, including up-to-date photographs of the premises, is attached at **Appendix 1**.
- 2.2 Fletchers Arms has been a Licensed Premises since 10 November 2005. Frederic Robinson Ltd has been the Premises Licence Holder since the licence was granted. A copy of the Premises Licence is attached at **Appendix 2**.
- 2.3 On 1 August 2005, an application was received by the Licensing Authority for an existing licence to be converted to a premises licence under the Licensing Act 2003 along with an application to vary the licence. A Panel hearing was held for these applications on 26 September 2005 following two representations from members of the public and one from Environmental Health. In addition, existing planning permission was considered at this time. Two conditions related to noise were added to the licence following this hearing. A copy of the planning permission document and the panel hearing outcome letter is attached at Appendices 3 and 4.
- 2.4 On 26 June 2023, Frederic Robinson Ltd submitted an application to vary the Premises Licence for the Fletchers Arms. The Applicant is seeking to update the plans that accompany the premises licence to reflect alterations that are being made to the internal layout of the site. These alterations involve the relocation of the bar to the wall abutting the rear beer garden area. In moving the bar, the entrance/exit to the beer garden will also be moved to the fire exit next to the toilet area on the premises. This existing fire door is being extended from a single door to a double door in order to meet fire regulations.

A copy of this application and the updated site plan is attached at **Appendix 5**.

2.5 In addition to the alterations to the site plan, the applicant is seeking to remove some conditions from the operating schedule and replace them with alternative conditions. A summary is provided in the table below:

Conditions to be removed	Conditions proposed
A sign will be displayed on the premises indicating the normal hours during which the sale of alcohol is permitted	The Challenge 25 policy is in operation so that if a customer purchasing alcohol appears to be under the age of 25, they will be asked for proof of their age, to prove that they are at least 18 years of age. The only forms of identification that will be accepted will bear their photograph, date of birth and a holographic mark and/or ultraviolet feature. Such examples of appropriate identification include a passport, photocard driving licence, military ID and Home Office approved proof of age ID card bearing the PASS hologram.
All fire doors will be maintained effectively self closing and shall not be held open other than by approved devices	
Notices detailing the actions to be taken in the event of fire or other emergencies, including how the fire brigade shall be summoned, are to be prominently displayed No one under the age of 18 will be allowed to enter or remain on the premises after 22:00 save on Christmas Eve and New Years Eve	

2.6 Five conditions have been proposed by the Licensing Authority but have not yet been accepted. A copy of these conditions is attached at **Appendix 6.**

3. REPRESENTATIONS & EVIDENCE SUBMITTED

Members of the Public

3.1 A representation has been received from 1 member of the public raising concerns with regards to the entrance/exit into the beer garden area being moved. This representation is attached at **Appendix 7**.

4. HOME OFFICE GUIDANCE

In determining this application the Panel must have regard to the Council's Statement of Licensing Policy and the statutory guidance issued pursuant to Section 182 of the Licensing Act 2003. The statutory guidance includes the following:

9.42 Licensing authorities are best placed to determine what actions are appropriate for the promotion of the licensing objectives in their areas. All licensing determinations should be considered on a case-by-case basis. They should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be.

9.43 The authority's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.


9.44 Determination of whether an action or step is appropriate for the promotion of the licensing objectives requires an assessment of what action or step would be suitable to

achieve that end. While this does not therefore require a licensing authority to decide that no lesser step will achieve the aim, the authority should aim to consider the potential burden that the condition would impose on the premises licence holder (such as the financial burden due to restrictions on licensable activities) as well as the potential benefit in terms of the promotion of the licensing objectives. However, it is imperative that the authority ensures that the factors which form the basis of its determination are limited to consideration of the promotion of the objectives and nothing outside those parameters. As with the consideration of licence variations, the licensing authority should consider wider issues such as other conditions already in place to mitigate potential negative impact on the promotion of the licensing objectives and the track record of the business. Further advice on determining what is appropriate when imposing conditions on a licence or certificate is provided in Chapter 10. The licensing authority is expected to come to its determination based on an assessment of the evidence on both the risks and benefits either for or against making the determination

5 CONCLUSION AND OPTIONS FOR THE PANEL

- 5.1 Panel are requested to consider the evidence and decide what (if any) steps to take as it considers appropriate for the promotion of the licensing objectives. The options available to the Panel are:
 - a) To modify the conditions of the licence
 - b) To reject the whole or part of the application





ANNEXES

Annex 1 – Mandatory conditions

Mandatory Conditions under the Licensing Act 2003:

(1) No supply of alcohol may be made under the premises licence:

(a)at a time when there is no designated premises supervisor in respect of the premises , or (b)at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

(2)Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 – Conditions consistent with the Operating Schedule

The prevention of crime and disorder

No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.

A sign will be displayed on the premises indicating the normal hours during which the sale of alcohol is permitted.

Public safety

All fire doors will be maintained effectively self closing and shall not be held open other than by approved devices.

Notices detailing the actions to be taken in the event of fire or other emergencies, including how the fire brigade shall be summoned, are to be prominently displayed.

The prevention of public nuisance

A sign will be located at the exit(s) requesting that customers leaving the premises do so quietly and with consideration to neighbours.

When live regulated entertainment is taking place after 22.00 windows and doors, save for entrance and exit purposes, will be kept shut.

The protection of children from harm

No one under the age of 18 will be allowed to enter or remain on the premises after 22.00 save on Christmas Eve and New Years Eve.

Anyone who appears to be under the age of 18 and who is attempting to buy alcohol must be required to produce proof of age before such a sale is made.

Condition as per written agreement following a representation from responsible authority

Noise generated by regulated entertainment shall be inaudible at the nearest noise sensitive location after 11.00pm

Annex 3 – Conditions attached after a hearing by the Licensing Authority

The Panel in reaching its decision took into account all the representations made, including photographic evidence, the Panel were satisfied that the applicant had taken adequate measures to prevent a break out of noise nuisance by installing a clear sound barrier with trees and shrubs. In addition the applicant shown evidence of signs erected in the car park area, requesting customers to leave the premise and shrubs. In consideration to local residents. In accordance with

the Councils Licensing Policy made the following decision:

(G) Performance of dance No application

Anything of a similar description to that falling within (e) (f) and (g) No application

- (I) Provision of facilities for making music No application
- (J) Provision of facilities for dancing No application
- (K) Provision of facilities for entertainment of a similar description to that falling within (i) and (j)No application
- (L) Late Night refreshment Sunday 23.00 to 23.30 hours

Monday to Saturday23.00 to 12 midnight

11.00 to 02.00 hours on all Bank and Public holidays including Christmas Eve, Boxing Day, Easter Monday and New Years Day and on any Sunday or Monday forming part of a Bank Holiday weekend.

(M) Supply of alcohol Sunday 12 noon to 23.30 hours

Monday to Saturday 11.00 to 12 midnight 11.00 to 02.00 hours on all Bank and Public holidays including Christmas Eve, Boxing Day, Easter Monday and New Years Day and on any Sunday or Monday forming part of a Bank Holiday weekend.

(O)Hours premises are open to the public Sunday 12 noon to 12 midnight







1. CCTV

(a) A tamper-proof digital colour CCTV system must be installed and maintained at the premises to the satisfaction of Greater Manchester Police.

(b) The system must run and record continuously for 24 hours a day, 7 days per week and recorded footage must be stored for a minimum of 28 days.

(c) The system must provide a clear head and shoulders view to an evidential quality on every entry/exit route and within any other vulnerable areas as identified by Greater Manchester Police.

(d) Recorded footage must be provided to a representative of any responsible authority on request. Such footage must be provided in an immediately viewable format and must include any software etc. which is required to view the footage. Any discs, portable drives or other storage media onto which footage is transferred must be provided by the premises and sufficient stock of such storage media must be kept on the premises at all times.

(e) A member of staff who is trained to operate the system and supply footage must be present at the premises at all times when licensable activities are taking place.

(f) The Designated Premises Supervisor must ensure that the CCTV system is checked at least once every month by a suitably trained member of staff. This check must include the operation of the cameras, the recording facilities, the facilities for providing footage and the accuracy of the time & date. A written record of these checks must be kept, including a signature of the person carrying out the check. This written record must be kept on the premises at all times and made available to a representative of any responsible authority on request.

(g) Suitable signage informing customers that a CCTV system is in operation must be placed in prominent positions within the premises, including information on the Data Protection Act and the Human Rights Act.

2. Incident Book

An incident book (with the pages numbered sequentially) must be kept on the premises and be made available for inspection by responsible authorities. The incident book must be used to record the following:

- (i) Any incident of violence or disorder on or immediately outside the premises
- (ii) Any incident involving controlled drugs (supply/possession/influence) on the premises
- (iii) Any other crime or criminal activity on the premises
- (iv) Any refusal to serve alcohol to persons who are drunk (On sale and off sale premises

only)

(v) Any refusal to serve alcohol to under 18's or anyone who appears to be under 18

- (vi) Any call for police assistance to the premises
- (vii) Any ejection from the premises
- (viii) Any first aid/other care given to a customer
- 3. Challenge 25

The premises must operate a "Challenge 25" scheme at the premise in relation to age verification for alcohol sales and other age-restricted products. Signs and/or posters must be displayed in prominent positions inside the premise to inform customers of this condition.

4. Staff Training

Any staff employed at the premises will receive training by the Designated Premises Supervisor on first appointment and at least every three months thereafter. Training will include input on preventing underage sales, sales of alcohol to people who are drunk, application of the drugs policy and any other relevant matters. A written record will be kept of all training carried out. This record must be kept on the premises and made available for inspection by any responsible authority.

5. List of Authorised Persons

The Designated Premises Supervisor must maintain a written record of all members of staff who are authorised to sell alcohol.
