In my capacity as Licensing Officer I have been made aware of numerous incidents which have been reported as occurring at / or in relation The Snipe Inn. As a result of knowing this on Tuesday 20<sup>th</sup> July 2021 I caused a search for incidents at The Snipe Inn, Audenshaw for dates between 1<sup>st</sup> January 2020 and 17<sup>th</sup> July 2021.

I have reviewed each of the incidents individually and the following are the list of incidents giving relevant detail of the reports in relation The Snipe PH Licensed Premises.

The majority of incident have occurred at weekend and have been recorded as occurring late in the evening and towards the terminal hour for the provision of alcohol.

The incident listed as 000391-06072021 relates to the above mentioned warrant. The premises closed on this date no further incidents have been recorded.

As of today Police investigations into this matter are ongoing.

To the best of my knowledge and belief there is no reasonable ground for believing that the information produced above, from various Police computer systems, and included in this statement is inaccurate because of improper use of the computers and to the best of my knowledge and belief at all material times the computers were operating properly, or if not, any respect in which they were not operating properly or were out of operation was not such as to effect the production of information produced or its accuracy.
