Statement of facts and affairs In chronological order

At the end of March 2022 I arranged to view the property named Mollys bar, 4-6 George street, Ashton under line with the landlord with an interest in renting the property. The previous tenants where evicted for none payment of rent and the landlord had a bailiff change all the locks prior to my visit.

A day later I had a phone call from the landlord saying that he has just had a call from the previous tenants threatened to burgle the place. He said what should I do should I 999 call the police, I said yes call the police

When I arrive at the property with the landlord the landlord found the previous tenants braking into the property round the back. It is threatened the landlord and the landlord call the bailiff and the bailiff said it was a burglary and told him to call the police. The landlord called the police and when the police arrived the previous tenants told the police that the property was already open. The police decided to take the side of the criminals and said it was a civil matter. The bailiff said they where allowed to remove personal items and stock only and they did. Then they left with the police. Later I agreed with the landlord to rent the property from him. Please note later on I found that the locks had been cut off inside with an angle grinder leading to the assumption that the criminals had planned this in advance

Several days later I was cleaning the property with the front doors open. and his gang turn up and he said we have come for our personal things. I said that try belongs to you and those jacks do est. est. They removed there personal things then one of them started removing the CCTV I said the landlord said they do not belong to you, he said they do I said I am calling the landlord and went outside. I dialled 999 and called the police and said I am being burgled. I went back inside where he was still removing the CCTV and said you are not authorised to removed that then came and pushed me aside and said try it! I said no sir.. Then another member of his gang a female jumped in and started screaming and shouting at me, I went out side and just then I could hear a police siren getting loader. The criminals jumped in there vehicles and left the seen very quick. I wrote there registration numbers on the back of my hand. Then the police arrived and I gave them the registration number and they did there stuff. The officer dealing with the case said we will need a statement from you at some point and took my details and my landlords details down. Please note to this date that the police have not been back in touch with me about this incident

Several days later when I was cleaning I found a brand new pair of boxing gloves. I decided to get my chopping knife and duck taped it to a pole to protect myself should the criminals attempt to break entry like they have threatened to do so

On the 12 of May 2022 I was in the property. I could hear someone braking in round the side and the roller shutter door going up. Straight away I dial 999 and picked up my knife on my pole and said on the phone I am being burgled and gave them my address. I then when up to the glass door where I could see 3 people stood there. I stood about 1 foot away from the glass holding my knife on a pole and said stop! Don't come any closer the police are on there way. One of them said is that a knife I said yes its a knife. He said can you put the knife down please. I said I don't know who you are. He said we are the gas company and we have come to remove the gas meter. I said I will put the knife down if you promise not to come any further. He said I do. I put the knife down and he said who are you. I said I am the new tenant. He said can you prove this I said I will show you my tenancy agreement so long as you promise not to proceed any further. He said I will. I showed him

my tenancy agreement and held it up to the glass and he took photos of it then we weighted for the police to arrive

The police arrived and bent coper said you are under arrest for affray. He did not read me my rights or caution me or asked if I understood and to the best of my knowledge this is an unlawful arrest. I was taken to the police station by 2 bent coppers. While I was in the police van bent copper was insistent to tell me that I will not by running Mollys bar and that it will never open again! Hence I conclude corrupt corporation (GMP) have made that decision prior to my arrest. Bent coper also said he knows the previous tenant and that one of closet relatives works for the police. Again I conclude that corrupt corporation (GMP) are protecting these criminal which would make sense why an office has not been back in tough with me to interview me about the previous burglary. While in the police van bent copper decided to lie to me about how I will be out of hear very soon. I got to the custody desk and the Sargent booked me in. I was then taken to a police cell where I weighted to be interviewed.

Bent copper came along and took me to the interview room. As the interview begun again bent copper did not read my my rights or caution me or ask if I understood. Bent copper did not interview me about the event and did not ask my any questions about what had happened. He was more interested in pointing out the fact the I know have the right to have a weapon to defend my self with.

I was taken to my police cell and weighted a while. Later on bent copper came along to lie to me again and said come on lets get you out of hear. When at the custody desk bent Sargent said we are charging you with common assault and because of the nature of the weapon we are keeping you in over night. Again to the best of my knowledge I do not believe this is a reasonable ground to keep me in over night and I will be raising this matter with my solicitor for my trial

I was kept in overnight and the morning after I was taken to court. When at court I asked for a solicitor and I was given one. I explained my side of event to him and he said this is not grounds for common assault and advised me to plea not guilty. When I was in the dock I pleaded not guilty and given unconditional bail and the trail was postponed. As I was taken down by the guard to be discharged the guard said that was bull shit! I then left the court
