1. ELECTION OF CIVIC MAYOR

It was moved by Councillor Cooney and seconded by Councillor Fairfoull that the appointment of the Civic Mayor for the Municipal Year 2022/23 be deferred until 6.00pm for the ceremonial part of the meeting.

2. APPOINTMENT OF CHAIR OF COUNCIL BUSINESS

It was moved by Councillor Cooney and seconded by Councillor Fairfoull and

RESOLVED

That Councillor Kitchen be appointed Chair of Council Business for the Municipal Year 2022/23.

3. CIVIC MAYOR'S ANNOUNCEMENTS

The Civic Mayor made reference to the fifth anniversary of the tragic Manchester Arena bombing attack, on Sunday 22 May 2022. The attack claimed the lives of 22 innocent people, the youngest of whom was just eight years old. In commemoration of the victims, whose lives would never be forgotten, Dukinfield Town Hall was lit yellow.

In terms of mayoral events, the Civic Mayor commented on her attendance at the Royal Garden Party at Buckingham Palace. She also mentioned the Last Night of the Proms evening, which had taken place on Saturday 21 May 2022 and the Annual Mayoral Ball, which had raised more than £8,000 for Cascade Baby Bundles and the Friends of Tameside Young Carers.

Other events attended included the Tameside Community Recovery Fund meetings in Ashton and Denton which dispensed several thousand pounds in much-needed grants to hard-working community groups.

The Civic Mayor made reference to her support of the Ukrainian community wherever possible, as they raised funds for friends, relatives and others in their homeland who were suffering as a

consequence of the Russian invasion.

The Civic Mayor thanked everyone involved in the smooth running of the recent local Council Elections on 5 May 2022, including those who worked on postal votes, the many roles surrounding polling stations, and all those who counted the votes.

The Civic Mayor paid tribute to three former Councillors: Jim Fitzpatrick, Philip Fitzpatrick and Dolores Lewis who ceased to be members of the Council following the elections on 5 May 2022. The Civic Mayor thanked them all for their dedication and wished them well for the future. The Civic Mayor also welcomed new councillors: Andrea Colbourne, Hugh Roderick and Lucy Turner.

7. APPOINTMENT OF EXECUTIVE LEADER

It was moved by Councillor Fairfoull and seconded by Councillor North and

RESOLVED

That Councillor Cooney be appointed as the Executive Leader of the Council for the Municipal Year 2022/23.

8. EXECUTIVE LEADER'S ADDRESS

The Executive Leader began by acknowledging the former Leader of Tameside Council, Councillor Brenda Warrington. He commented in particular on major events of the last four years, including the untimely death of the former Leader of the Council, Kieran Quinn, the collapse of Carillion and the Coronavirus pandemic and thanked Councillor Warrington for steering the Council through unprecedented times with tremendous fortitude.

The Executive Leader emphasised the need to build on the work of the last four years and highlighted four key areas of focus, going forward:

- Town Centres;
- Major Projects;
- Clean and Safe Streets; and
- Listening to the voice of residents.

He pledged to build on the unique strengths of town centres and the swift delivery of major projects. Talking to residents had identified areas of concern including; cleaner streets and taking firm action on fly tipping and anti-social behaviour.

The Executive Leader further gave assurances in respect of opening up the decision making process to ensure residents voices were heard, on the issues important to them.

The Executive Leader concluded by making reference to the Queen's Platinum Jubilee and of plans to work with the Lord-Lieutenant of Greater Manchester to find a way to formally recognise Her Majesty's historic public service.

9. APPOINTMENT OF EXECUTIVE CABINET, PANELS, STANDARDS COMMITTEE, OUTSIDE BODIES AND OPPOSITION SPOKESPERSONS

The Chair of Council Business formally thanked Valerie Bracken, the Independent Person and Chair of the Standards Committee and her deputy Jacqueline Barnes, who had served the Council for over a decade in supporting and raising standards. He further welcomed Mirriam Lawton, who had been appointed as the new Independent Person and Chair of Standards Committee and her deputy, who would be appointed in due course.

RESOLVED

That the Minutes of the meeting of Standards Committee held on 5 April 2022 be signed by the Chair of Council Business as a correct record.

13. REVISED GAMBLING ACT STATEMENT OF PRINCIPLES

Consideration was given to a report of the Director of Place, which explained that Licensing authorities were required to develop, consult on, and publish a Statement of Principles every three years that set out the principles they proposed to apply in exercising their functions under the Gambling Act 2005.

It was further explained that, in preparing the Statement, the Authority had to have regard to codes of practice and guidance issued by the Gambling Commission. The Statement reflected collaboration across Greater Manchester with, for the first time, a joint Statement of Gambling Principles approved at local level. The aim of this was to provide a more consistent policy position across Greater Manchester; with the shared aim of preventing and reducing the negative impacts of gambling on individuals, families and communities.

A copy of the proposed Gambling Statement of Principles was attached at Appendix 1 to the report.

Details were given of the 8 week consultation process, which had taken place between 29 November 2021 and 24 January 2022 and copies of responses received were appended to the report.

An Equality Impact Assessment (EIA) had been completed showing there was no adverse impact on the community. The EIA form was also appended to the report.

RESOLVED:

That the Gambling Statement of Principles, as appended to the report, be adopted.

14. REVISED STATEMENT OF LICENSING POLICY – LICENSING ACT 2003

The Director of Place submitted a report, which explained that Licensing authorities were required to prepare, consult on, and publish a Statement of Licensing Policy every five years. The policy detailed how the Council would administer and enforce the provisions of the Licensing Act 2003.

Members were advised that Tameside Council's Statement of Licensing Policy was last revised in January 2016. Due to the impact of the coronavirus pandemic a full review of the Licensing Policy was unable to take place, therefore the policy was extended for a period of 12 months in May 2021.

The revised draft policy reflected recent changes to legislation including the Immigration Act 2016. The most significant change was the proposed removal of the Cumulative Impact Policies (in Stalybridge town centre and Ashton-under-Lyne town centre).

A copy of the proposed Statement of Licensing Policy was attached at Appendix 1 to the report.

Details were given of the 8 week consultation process, which had taken place between 29 November 2021 and 24 January 2022 and copies of the response received was appended to the report.

An Equality Impact Assessment (EIA) had been completed showing there was no adverse impact on the community. The EIA form was also appended to the report.
