Licensing have been working closely with the premises licence holder to provide advice and support in order to achieve compliance and ensure the promotion of the licensing objectives.

On 7 September 2022, Greater Manchester Police seized a vehicle which was parked a the rear od Save More Convenience Store, 75-77 Market St, Droylsden. A quantity of illicit tobacco and cannabis was found inside the vehicle.

In order to investigate this matter further, a request was made to view the CCTV footage from the premises because Officers noticed that a camera was covering the area where the vehicle was parked. Unfortunately, Mr Abdi, who identified himself as the business owner, was unable to comply with the request because he informed the Licensing Officer that he did not know where the CCTV hard drive was located.

At the time of the visit on 7 September 2022, a compliance check was carried out and Mr Abdi was advised to suspend alcohol sales due to the Premises Licence Holder and DPS on the licence no longer being associated with the business alongside 7 conditions on the licence not being complied with.

On 9 September 2022, the Licensing Authority received a transfer application and an application to vary the DPS, however Mr Abdi was advised that the premises licence conditions were still not being complied with and therefore if alcohol was sold from the premises, this would be in breach of the licence.

The Licensing Authority were informed that alcohol was still being sold from the premises and a test purchase was carried out on 14 September 2022, where a bottle of wine was purchased.

A follow up Compliance visit was carried out on 14 September 2022, and while some improvements were noted, the premises was still non-compliant with 3 conditions.

Mr Abdi was further advised on 14 September to cease sales until all conditions were fully complied with.

A further test purchase was carried out on 22 September 2022 where a bottle of blue WKD was purchased.

A further compliance visit was carried out and the following conditions were still <u>not</u> being complied with:

- CCTV not storing footage for 28 days minimum, no person on site able to demonstrate system, record/burn footage to a storage device, no CCTV check sheet with weekly checks completed, no CCTV signage
- Staff Training no records available

Mr Abdi was informed that the Licensing Authority were losing confidence in the ability of the management of the premises to promote the licensing objectives and becoming increasingly concerned that advice and support was being ignored.

On 13 October 2022, the following illicit and illegal tobacco products were seized from the premises as part of an operation to tackle the sale of illicit tobacco:

9 x packets amber leaf 50g 8 x packets Marlboro Gold

12 x packets Richmond

2 x packets L&B

10 x packets L&M

13 x packets NZ gold - all in carrier bag in rear yard

5 x packets Richmond

2 x packets L&B - in coat behind counter.

67 ELUX 3500 - non-complaint vapes

Following this seizure a Licensing Officer carried out a compliance visit and found that the premises remained non-compliant with the conditions of the licence including;

CCTV

Staff Training

Cider above 7.5% was on sale

In addition to the above, Mr Abdi did not understand what the Challenge 25, age verification policy meant which the licensing officer found concerning. In addition, Mr Abdi informed the officer that FAKHERADDIN QAZIZADEH, the Designated Premises Supervisor nominated on 9 September 2022 is not involved in the business in any capacity.

Due to the consistent and flagrant disregard for the licensing objectives, the Licensing Authority has lost confidence in Mr Abdi to promote the licensing objectives.

Further evidence will be supplied to support this application.
