ANNEXES

Annex 1 – Mandatory conditions

Mandatory Conditions under the Licensing Act 2003:

(1) No supply of alcohol may be made under the premises licence:

Annex 2 – Conditions consistent with the Operating Schedule

The prevention of crime and disorder

No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.

A sign will be displayed on the premises indicating the normal hours during which the sale of alcohol is permitted.

Public safety

All fire doors will be maintained effectively self closing and shall not be held open other than by approved devices.

The protection of children from harm

No one under the age of 18 will be allowed to enter or remain on the premises after 22.00 save on Christmas Eve and New Years Eve.

Anyone who appears to be under the age of 18 and who is attempting to buy alcohol must be required to produce proof of age before such a sale is made.

Condition as per written agreement following a representation from responsible authority

Noise generated by regulated entertainment shall be inaudible at the nearest noise sensitive location after 11.00pm

Annex 3 – Conditions attached after a hearing by the Licensing Authority

The Panel in reaching its decision took into account all the representations made, including photographic evidence, the Panel were satisfied that the applicant had taken adequate measures to prevent a break out of noise nuisance by installing a clear sound barrier with trees and shrubs. In addition the applicant shown evidence of signs erected in the car park area, requesting customers to leave the premises quietly with consideration to local residents. In accordance with
