The terms of this agreement are to reflect the terms of the contract where possible and to include adsorbing any risk items, except in the unlikely event of the contract not proceeding for any reason, then you would be paid on a Quantum Meruit basis for any costs that you incurred as accepted and agreed by Albany SPCS Ltd but subject approval of Prosiect Consult Ltd.

The formal Contract Documents will be prepared for your execution.

Please acknowledge receipt of this letter and confirm your agreement to be bound by the foregoing by countersigning and returning it to the undersigned as soon as possible.
