**Report Summary:** The report details the schedule for the delivery of the

> Pharmaceutical Needs Assessment (PNA) 2022-2025 and Terms of Reference for the steering group that has been

created, which can be found at Appendix 1.

Recommendations: The Health and Wellbeing Board note the intention to

produce a Pharmacy Needs Assessment in line with The National Health Service (Pharmaceutical and Local

Pharmaceutical Services) Regulations 2013.

The Pharmaceutical Needs Assessments was due to be renewed and published by the Local Authority Health and

Wellbeing Board in April 2022.

Due to ongoing pressures across all sectors in response to the COVID-19 pandemic, the requirement to publish renewed Pharmaceutical Needs Assessments has been suspended until October 2022. Therefore, we will start to work on the revised needs assessment from September 2021 with a publication date for the 2022/25 PNA date being

October 1 2022.

From 1 April 2013, Tameside Health and Wellbeing Board has a statutory responsibility to publish and keep up-to-date a statement of the needs for pharmaceutical services for the population in its area, referred to as a 'pharmaceutical needs assessment' (PNA).

The PNA will be used by NHS England in its determination as to whether to approve applications to join the pharmaceutical list under The National Health Service (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013. The relevant NHS England Area Team will then review the application and decide if the application meets the regulatory criteria for approval. When making the decision NHS England is required to refer to the local PNA.

- 1.3 The PNA was due to be renewed and published by Local Authority Health and Wellbeing Boards in April 2022. However, due to ongoing pressures across all sectors in response to the COVID-19 pandemic, the requirement to publish renewed PNAs was suspended until October 2022. Work on the revised needs assessment began in September 2021 with an expected publication date of October 2022.

#### 2. BACKGOUND

## 3. SCHEDULE

- 3.1 The schedule for the delivery of the Pharmaceutical Needs Assessment (PNA) 2022-2025 is set out below:
  - 1. Planning for the 2022/2025 PNA start date September 2021
  - PNA steering group meetings start September 2021, which will be held approximately every 2-3 months until sign off of the PNA
  - 3. Pharmacy public consultation to take place between mid-May and mid-June 2022
  - 4. First Draft PNA will be available for consideration from July 2021
  - Stakeholder consultation will take place for 60 days in July and August 2022.
  - 6. Final draft will be completed by mid-September 2022
  - 7. Sign off of the PNA 2022/2025 will go to the local Health and Wellbeing Board in September 2022 (date to be confirmed)
  - 8. PNA 2022/2025 will be published on the 1 October 2022

3.2 A Steering Group has been established to lead this work, which will provide clear recommendations on the pharmaceutical requirements across Tameside. The Terms of Reference of the group can be found at **Appendix 1.**
